

Supergroup 2: City Living

The members of this supergroup can be found within city areas of England and Scotland, especially within London. The supergroup comprises of 2 groups, 2a (2 subgroups) and 2b (2 subgroups). There are 19 wards that have all their output areas classified in this supergroup including, Aldersgate, Bishopsgate, Cripplegate, Farringdon Within, Farringdon Without, Hillside, Queenhithe, Tower and Walbrook in London, Brunswick and Adelaide, Central Hove, Regency and Holywell in the South-East, New Town, Marchmont and Hillhead in Scotland, Clifton East and Central in the South-West and Aberystwyth Canol/Central in Wales. Within this supergroup:

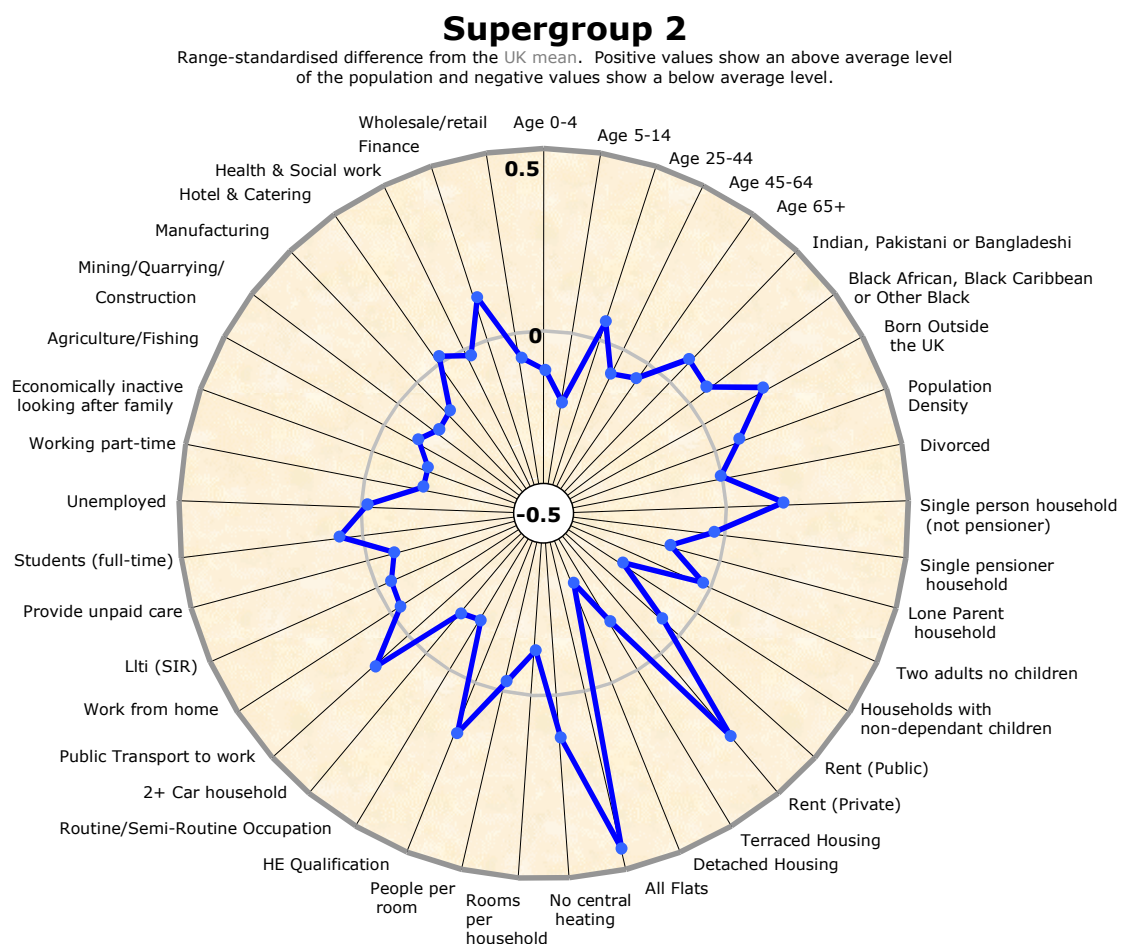

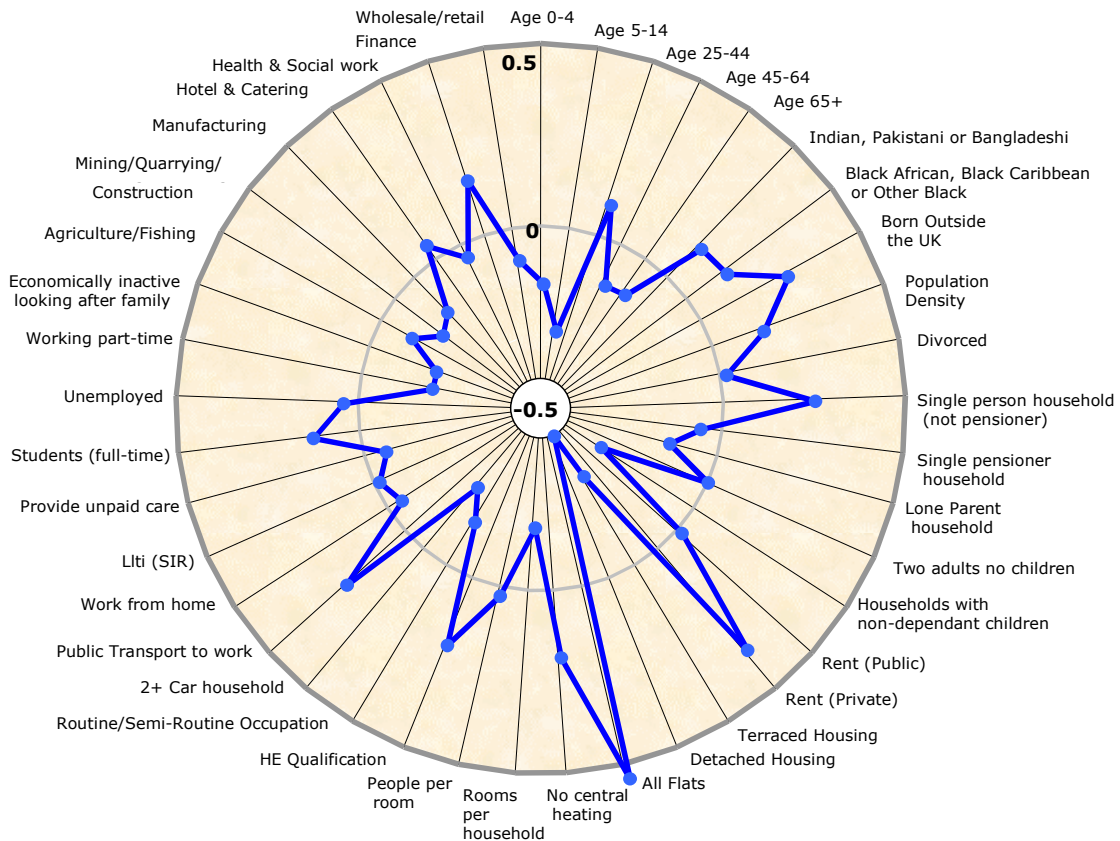

The members of this group can be found around cities of England and Scotland. There is one ward, Farringdon in London, that has all its output areas classified in this group. There are 13 other wards that have 70% or more including Central, Folkestone Harvey Central, Folkestone Harvey West, Heene and St Margaret's in the South-East, Chiswick Homefields and Twickenham Riverside in London, St James and Westbourne and West Cliff in the South-West, St Nicholas in North-East, Ramshill in Yorkshire and the Humber, St Andrews Central in Scotland and Menai (Bangor) in Wales. 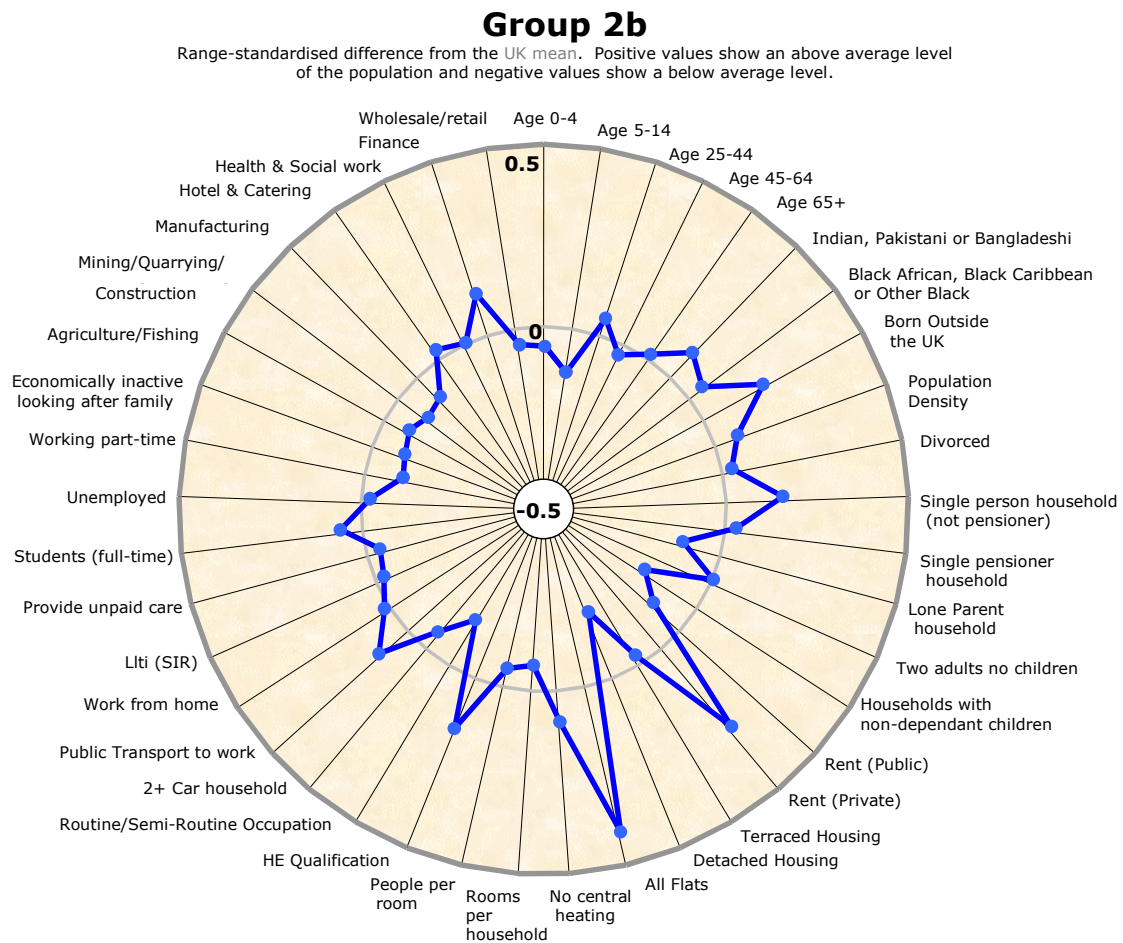

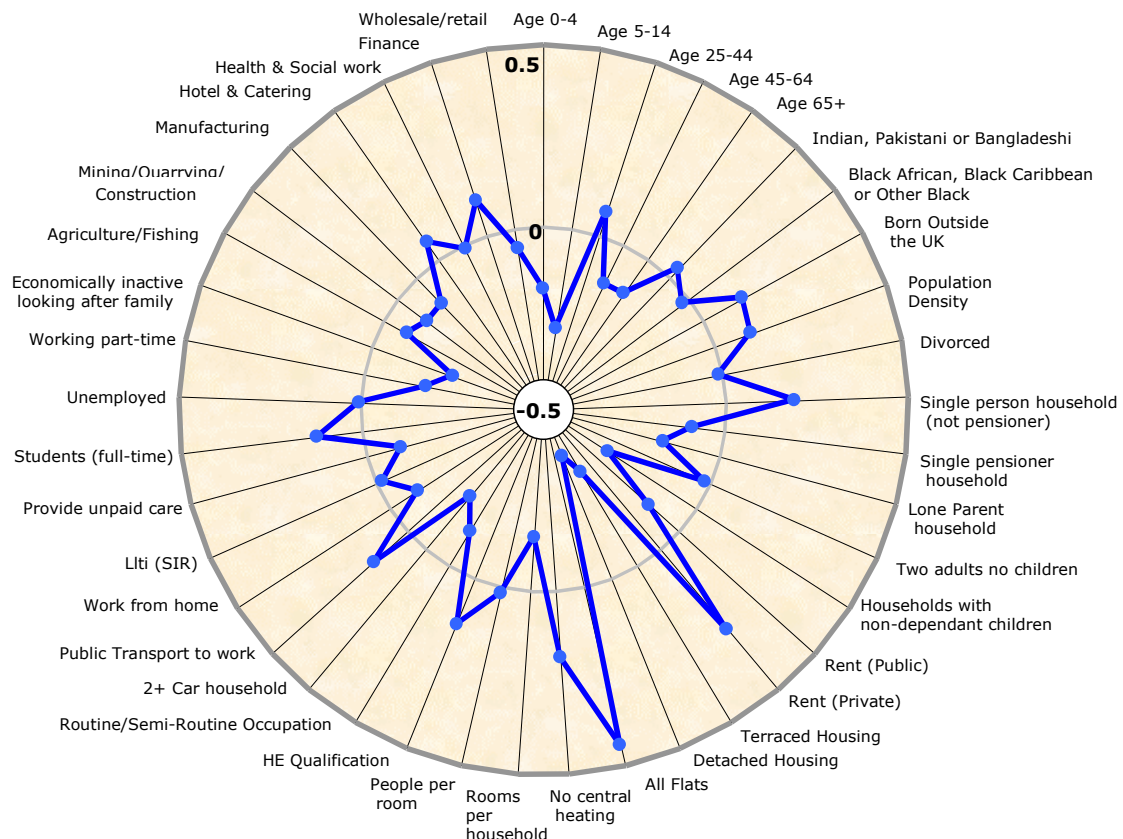

There is one ward, Warwick in London, that has 89% of its output areas classified in this subgroup. There are another 8 wards that have 70% or more including Bryanston and Dorset Square, Courtfield, Cripplegate, Earl's Court, Lancaster Gate, Marylebone High Street, Queen's Gate, and West End with all being in London. Within this subgroup:

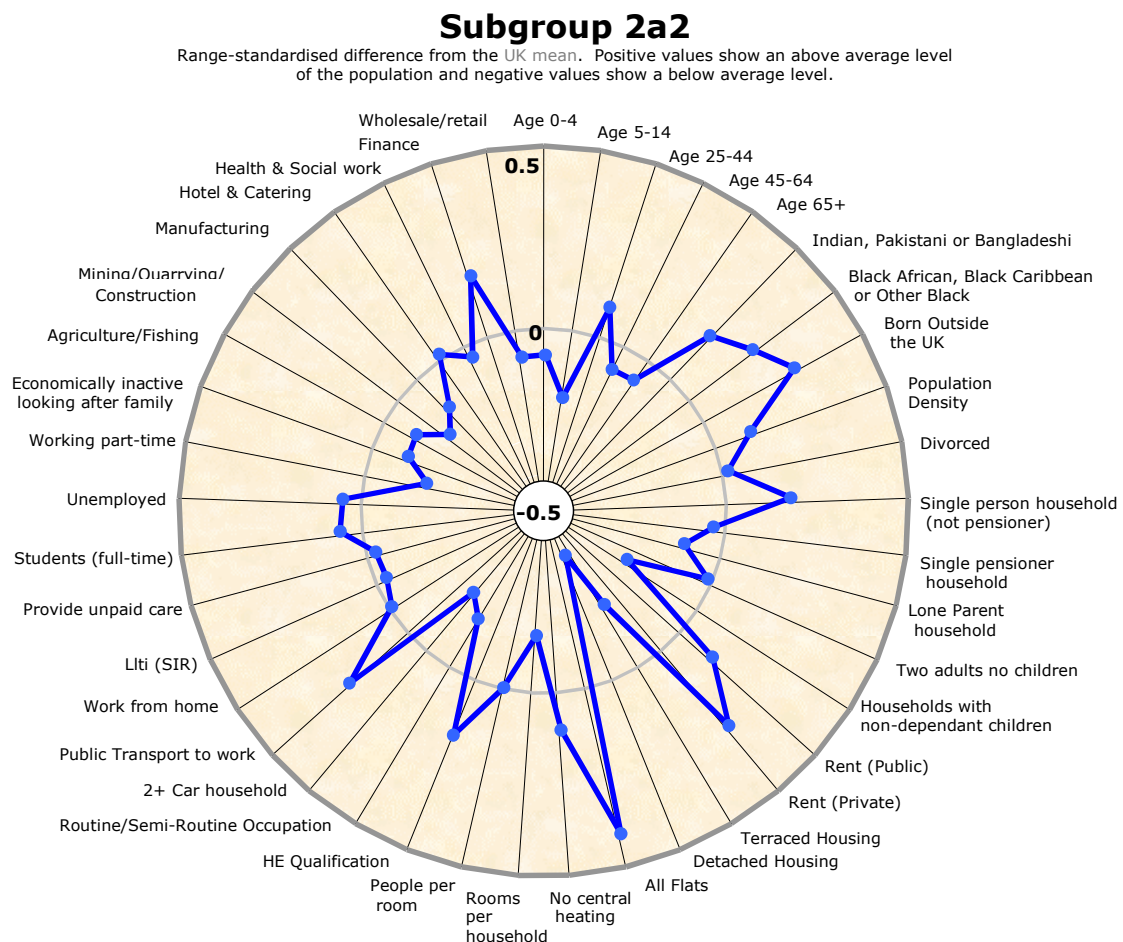

Subgroup 2b1: Settled in the City (1)

There is one ward, Ramshill in Yorkshire and the Humber, that has 82% of its output areas classified in this subgroup. There are 5 other wards that have 65% or more including Folkestone Harvey Central, Folkestone Harvey West and Marine in the South-East, Westbourne and West Cliff and Weston-super-Mare West in the South-West. 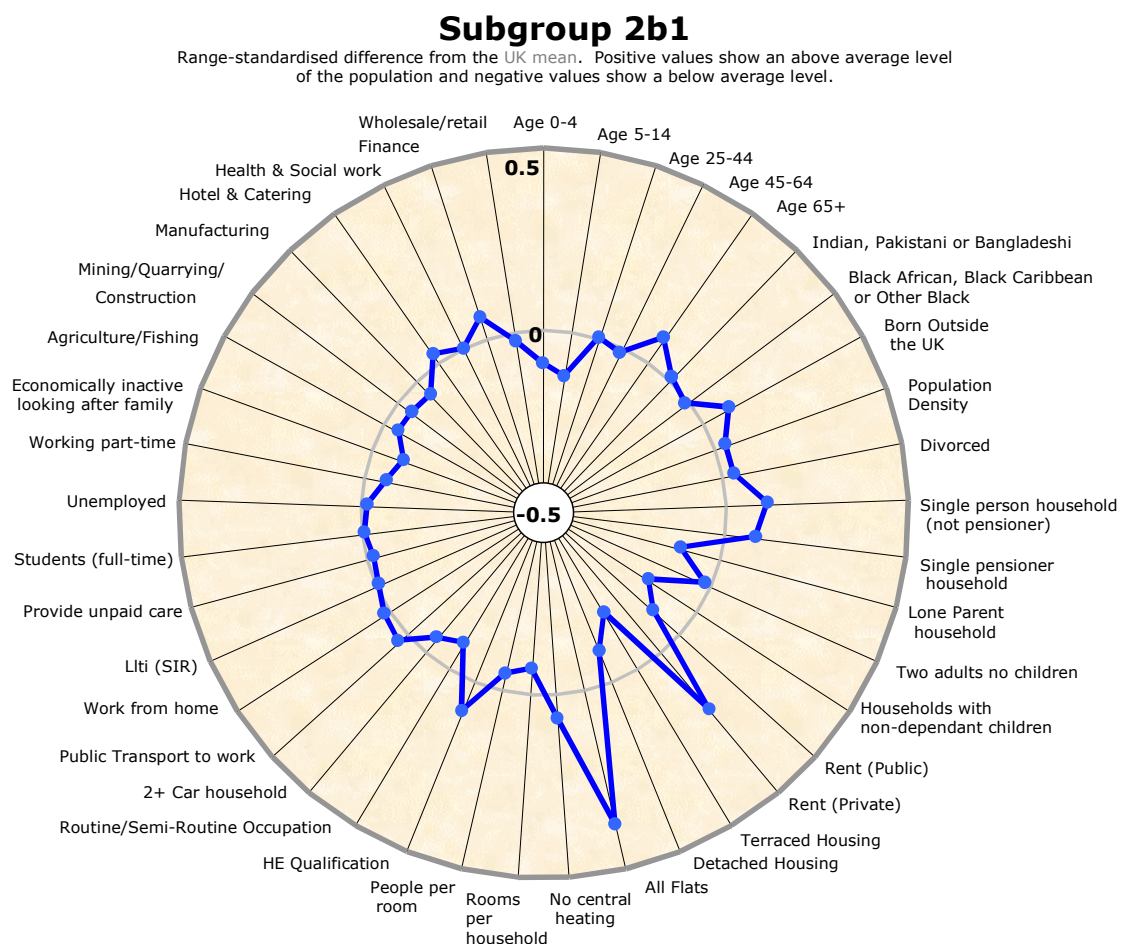

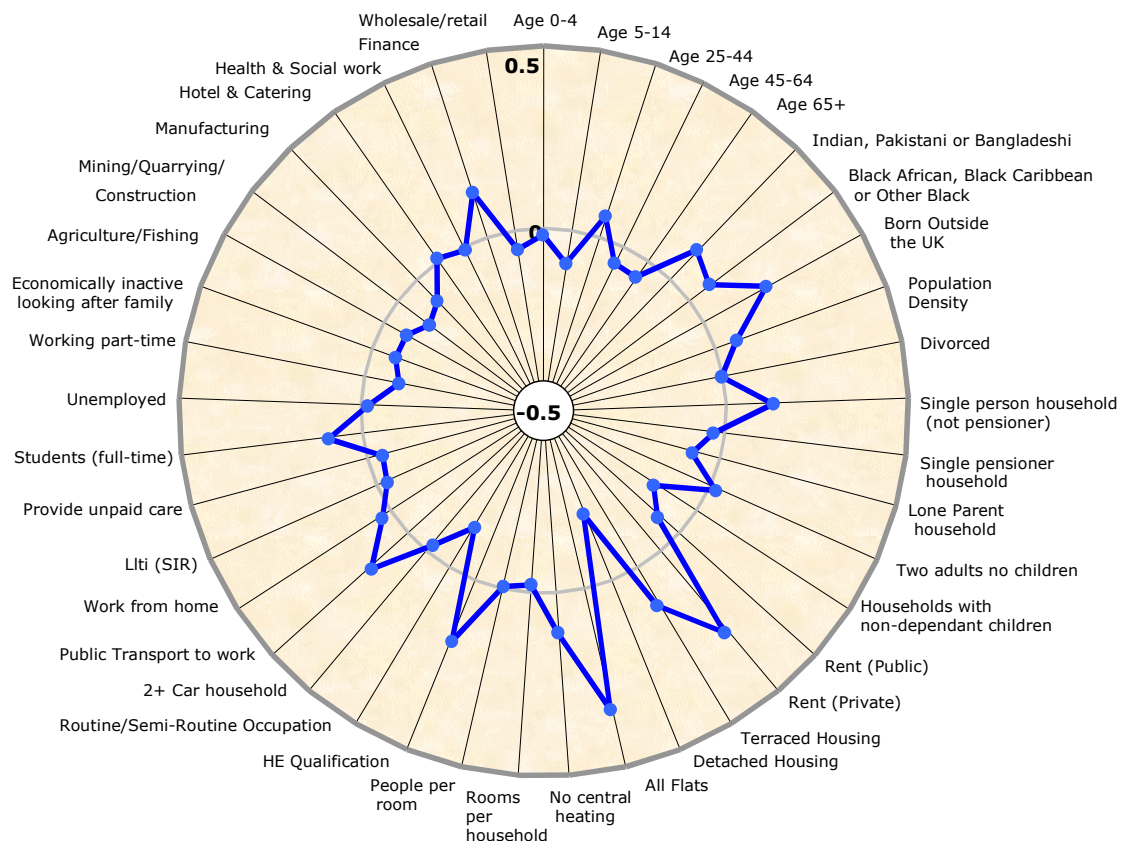
