

## Supergroup 7: Multicultural

The members of this supergroup can be found concentrated around major cities of England in particular London and Birmingham. The supergroup comprises of 2 groups, 7a (3 subgroups) and 7b (2 subgroups). There are 67 wards across the UK that have all their output areas classified in this supergroup including 60 in London, 4 in the West-Midlands, 2 in the North-West and 1 in the South-East. Within this supergroup:

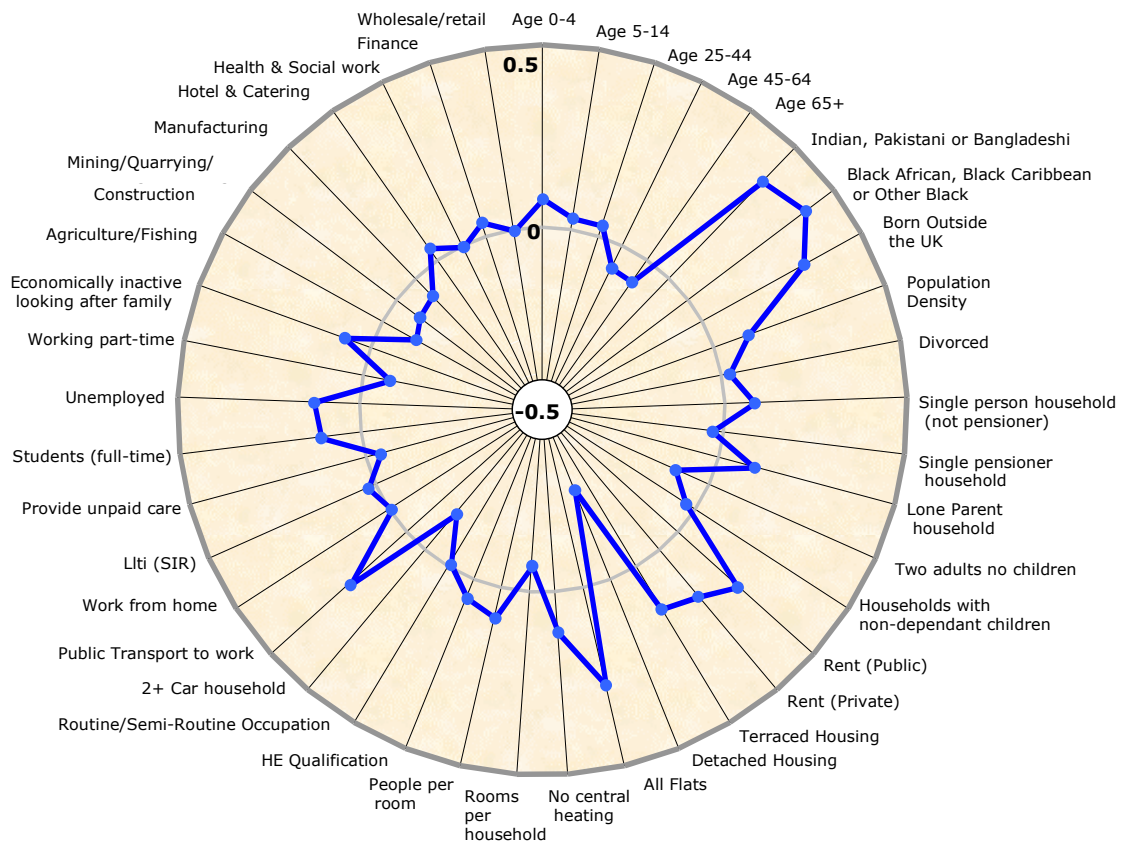

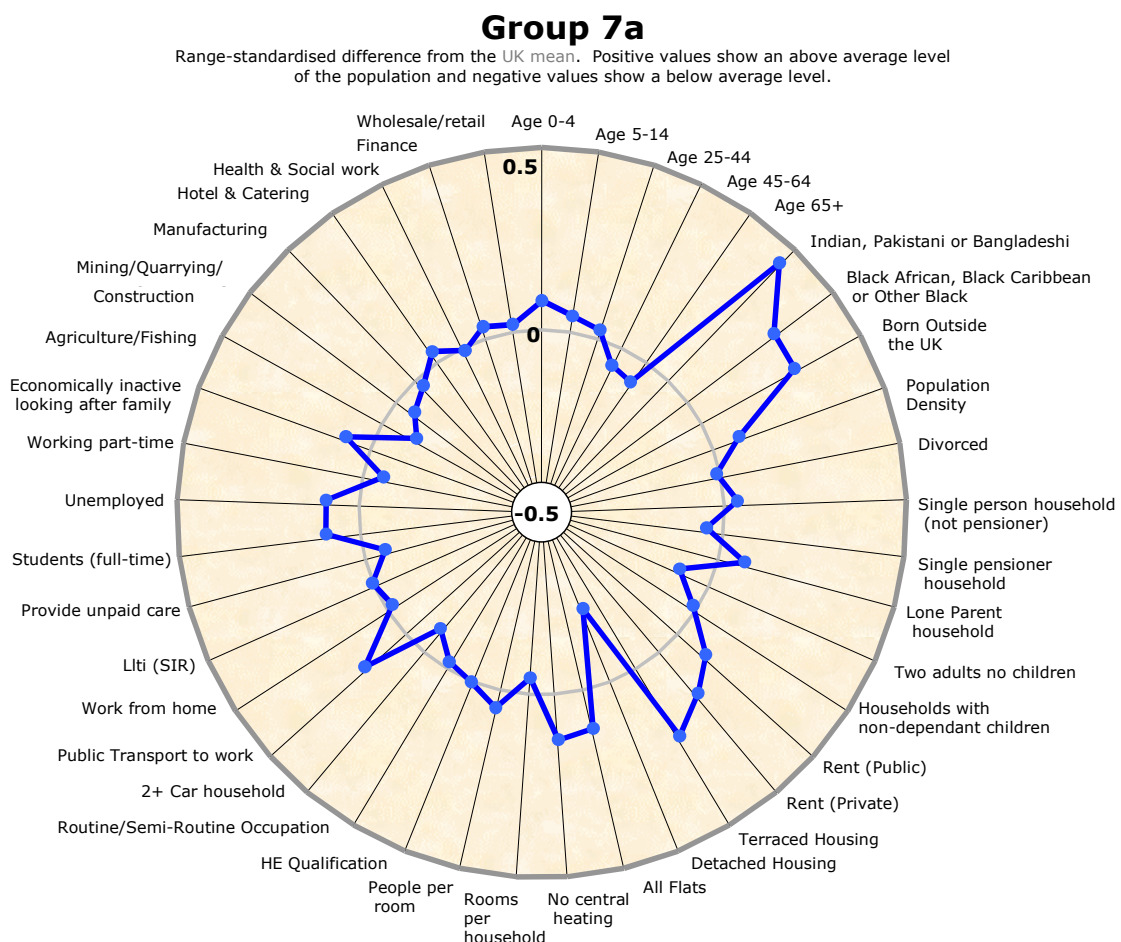

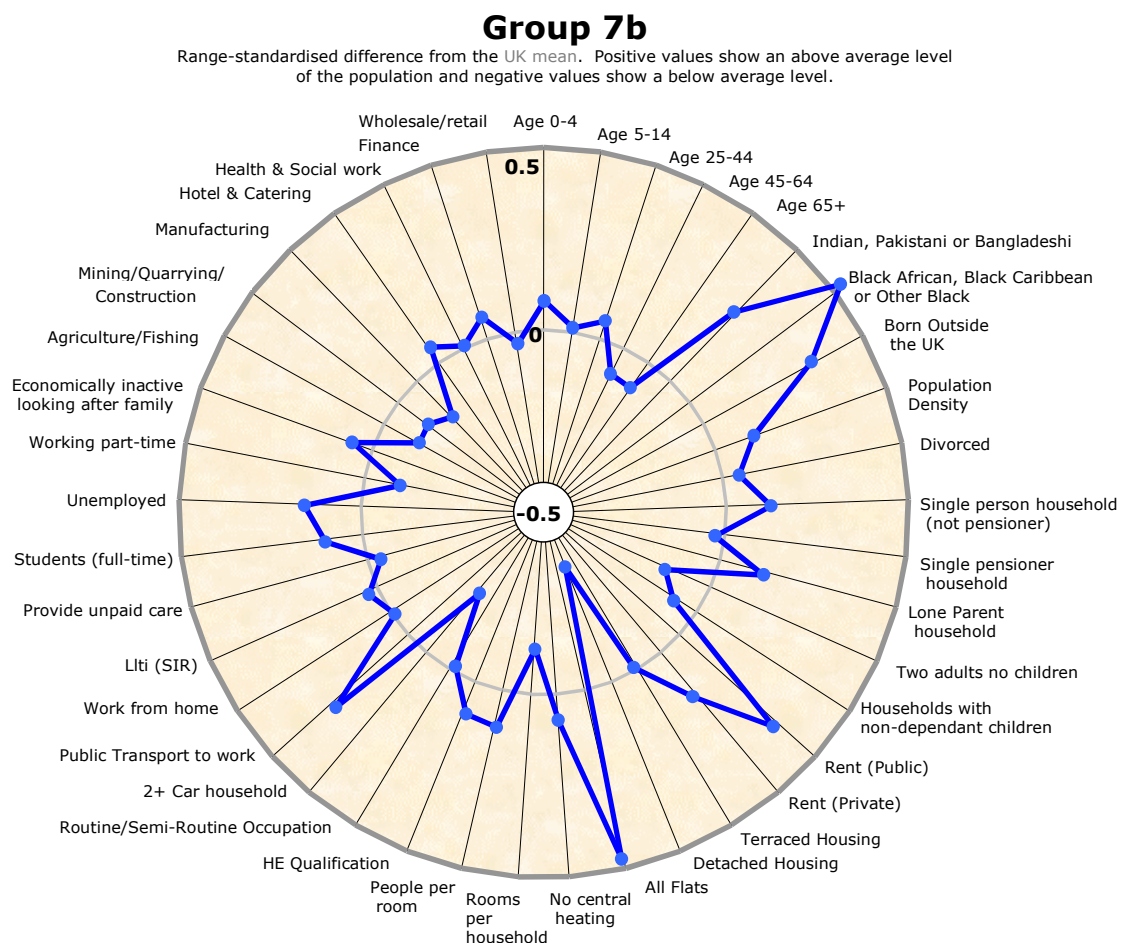

There is one ward, Daneshouse with Stoneyholme in the North-West, that has all its output areas classified in this subgroup. There are 8 other wards that have 80% or more including Bradford Moor and University in Yorkshire and the Humber, Belgrave and Latimer in the East-Midlands, Foleshill and Small Heath in the West-Midlands, Whitefield in the North-West and Dallow in the East of England. 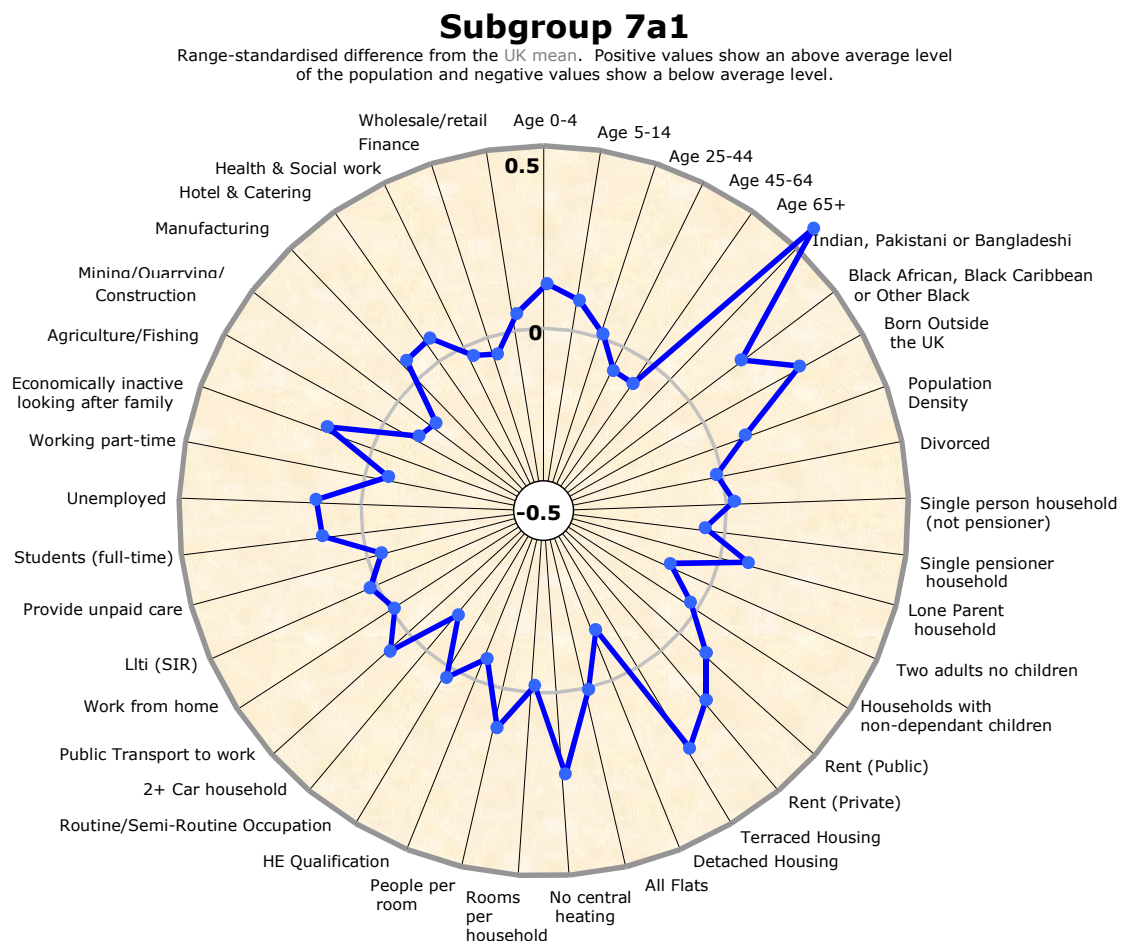

There are 6 other wards that have 50% or more including Becontree, Burnt Oak, Higham Hill and St Helier in London, Burnage in the North-West and Northwell in the East of England.
